## Green Party Terms & Conditions

1. I wish to join the Green Party and I accept the principles of the Green Party and the Party's constitution.
2. I declare that I am not a member of another political party.
3. I confirm that my permanent address is in Ireland or I am an Irish citizen living abroad.
4. The minimum age for membership of the Green Party is 16. I confirm that I am 16 years of age or older.
5. Membership can be cancelled and payment refunded in full if requested within 7 days of joining the Party. Please email [info@greenparty.ie](mailto:info@greenparty.ie) for the refund. The money will be refunded to the payment card used. After 7 days, no refund will be given. This does not affect your statutory rights. Should a conflict arise, your statutory rights will supersede these terms and conditions.
6. Members Portal at [my.greenparty.ie](http://my.greenparty.ie) will be available once the membership payment is processed.
7. By joining the Green Party, you agree to the GDPR policy outlined below.
8. I understand that Green Party will contact me via these means as part of the membership contract:
  - a. Green Party Head Office (HO) communications:
    - i. email address – primary communication method:
    - ii. service message about payments: e.g. notice of payment collection, receipt for payment, failure of payment.
    - iii. service message about membership e.g. confirmation of membership application, membership status update – probation, grace.
    - iv. service message about forthcoming member event, e.g. notice of Policy Council meeting – agenda, minutes.
    - v. message regarding political updates e.g. national update from spokesperson, message from leader of the Party.
    - vi. mobile number – personal communications and reminders (e.g. membership or payment issue).
    - vii. postal address/eircode – secondary communication method (e.g. welcome letter and pack from HO, reminder to renew membership, ballots for postal elections if required for selection of a senior Party officer e.g. leader).
  - b. Green Party Officers process member data for essential services:
    - i. email address – used as the primary mode of communication (e.g. new member welcome from the constituency group).
    - ii. postal addresses/eircode – used as secondary mode of communication (e.g. analysing the distribution of members across the constituency and setting strategic goals).
  - c. Processing of member data by Elected or Unelected Party Representatives and Candidates for essential services:
    - i. Email Address – used to stay in touch with local members.
    - ii. Phone number – used for personal communications with members. Not to be used for canvassing without consent.
