An Act to provide for a ban on single-use non-compostable cups and other tableware and for the introduction of deposit and return schemes for beverage containers. 5

Be it enacted by the Oireachtas as follows:

Definitions

1. In this Act—

“Act of 1996” means the Waste Management Act 1996; 10

“Minister” means the Minister for Housing, Planning, Community and Local Government.

Expenses

2. The expense of the Minister in the administration of this Act shall, to such extent as may be sanctioned by the Minister for Public Expenditure and Reform, be paid out of moneys provided by the Oireachtas. 15

Ban on disposable non-compostable tableware

3. The Minister shall make regulations in exercise of his/her powers under section 29 of the Act of 1996 to require that the sale or free distribution of disposable plastic cups, glasses, plates and other tableware is forbidden from 1 January 2020, except for items which can be disposed of by composting in an ordinary domestic compost facility. 20

Deposit and return schemes

4. By 1 July 2019 the Minister shall make regulations in exercise of his/her powers under section 29 of the Act of 1996 to provide for a deposit and return scheme for sealed containers in which beverages are sold. 25

Short title

5. This Act may be cited as the Waste Reduction Act 2017.

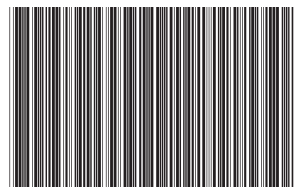
